3. The sealed quotation should be addressed to Executive Engineer, Engineering Cell, Sikkim University, 6th Mile, Samdur, Tadong, Gangtok, Sikkim – 737102 should reach the University on/before **09/03/2018** failing which the participation will stand cancelled.
4. Bidders are not required to submit EMD while bidding, whereas after the award of Work order, the EMD of the successful bidder shall be retained as security till completion of the defect liability period and shall be returned upon the written request of the successful bidder.
Defects liability period shall be 6month from the date of completion of work.
5. The rate should be quoted including all costs such as labour charges, materials, transportation, GST etc. No other charges shall be entertained under any circumstances.
6. 5% of the final bill value of the successful bidder shall be retained as security against the work done. The same shall be released after completion of 6 months of defect liability period.
7. No interest shall be paid by the University on any deposits held as security against the work.
8. Successful bidder should complete the work within 15 days from the date of issue of the work order.
9. Full and final payment shall be made only after completion of the entire work & award of completion certificate by authority concerned. No advance/part payment shall be made.
10. Construction materials should be reputed make & ISI marked.
11. Work should be done under the supervision of Engg. Cell Sikkim University.
