7. 24 x 7 Email and telephonic support should be provided for all forms of technical work and troubleshooting work related to the service.
8. Refund of EMD amount will be done on the written request of the participating bidder after the tendering process is completed.
9. Payment of services (hosting + SSL) will be made after the end of the service period on submission of invoices by the awarded vendor. All other financial matters of this tender (like Performance Guarantee amount, payment terms and conditions etc.) will be governed by the work order and LSCSLA document.
