The CAG vide letter no. Comm/CABs/22-23/04 dated 26.05.2022 has directed the Autonomous Bodies to submit Annual Accounts within the stipulated date i.e. 30<sup>th</sup> June for Statutory Audit to ensure that the Audited Annual Accounts along with SAR can be placed in the Parliament without delay.

Given the above, the Annual Accounts for the year 2021-22 was circulated among the Hon'ble members of the Finance Committee on 07.06.2022 through e-mail for kind consideration and recommendation to place before the Executive Council for approval. The observation of audit, if any, shall be complied at the instance of audit.
